I want to thank you for your interest in St. Pius X Catholic School and your dedication to Catholic education. For over fifty years, St. Pius School has played an important role in the lives of many families. The Sisters of Charity instilled within these walls that Goodness, Discipline and Knowledge are the key ingredients for a strong foundation in education. Today, the faculty, staff, and parents of St. Pius agree that these ingredients are still important.

When your child enters St. Pius X Catholic School in August, you can rest assured he/she is entering an environment in which Christ is the central focus for all that we do. We begin and end each day with school wide prayer and participate in class led prayers, the students prepare and attend weekly Mass, and they participate in many other liturgical celebrations throughout the year.

Your child will have access to state of the art technology. At St. Pius, we believe technology enhances the curriculum and instruction and will challenge your child in his/her studies. Your child will have Internet access in our computer labs and library, and all of our classrooms offer Smart Board technology with interactive capabilities. We offer the Sycamore Education student-information-system, which is an Internet information system with 24-hour access to grades.

A caring community of students, faculty, staff and volunteers, who are dedicated and committed in providing each child a quality Catholic education, surrounds your child at St. Pius X Catholic School. St. Pius X nurtures your child in a loving atmosphere that feels like a home away from home. Each child at St. Pius X is treated with respect and dignity.

We strive to make a Catholic education accessible and affordable to all who desire it. Therefore, we offer three tuition option based on household income. These rates will support families who are in need of financial assistance. Families earning less than \$75,000 are eligible to pay the tuition rate in option 3 and families earning between \$75,000 and \$95,000 are eligible for the tuition rates in option 2. To qualify for these lower tuition rates, and to apply for any additional financial aid that MIGHT be available, families must fill out the attached financial aid application and return it to the office along with a copy of your 2016 taxes. These will be used to determine eligibility for financial aid.

Attached is an application for our school, along with other important documents. Please return your completed application, along with all requested forms, as soon as possible. Applications for admission will be reviewed, and selected candidates will be notified. Open slots will be filled on a first come, first served basis. If we do not have a current opening, we will offer you the option to put your name on a waiting list. No registration fee will be charged until acceptance has been guaranteed. New students may be tested to ensure academic readiness prior to acceptance. We will contact you if this is deemed necessary for your child. A \$10 testing fee will apply.
